


1. We are the chairman of the board, vice chairman of the board, treasurer and secretary, respectively, of G.G.R.C. Program Policy Committee, Inc., a California corporation.

2. Article VII of the Articles of Incorporation of this corporation, amended April 4, 1978, is hereby further amended to read in its entirety as follows:

This corporation is not organized, nor shall it be operated, for pecuniary gain or profit, and it does not contemplate the distribution of gains, profits, or dividends to the members thereof and is organized solely for nonprofit purposes. The property, assets, profits, and net income of this corporation are irrevocably dedicated to charitable purposes and no part of the profits or net income of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private shareholder or individual. Upon the dissolution or winding up of this corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 23701d of the Revenue and Taxation Code and/or Section 501(c)(3) of the Internal Revenue Code. If this corporation holds any assets in trust, such assets shall be disposed of in such manner as may be directed by decree of the Superior Court of the county in which this corporation's principal office is located, upon petition therefor by the Attorney General or by any person concerned in the liquidation.




3. The amendment has been approved unanimously by the board of trustees.

4. The board of trustees alone was entitled to adopt the foregoing amendment for the reason this corporation has no members as that term is defined by Corporations Code Section 5310.

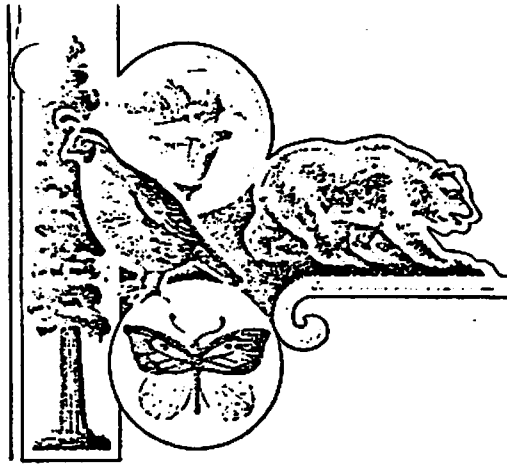
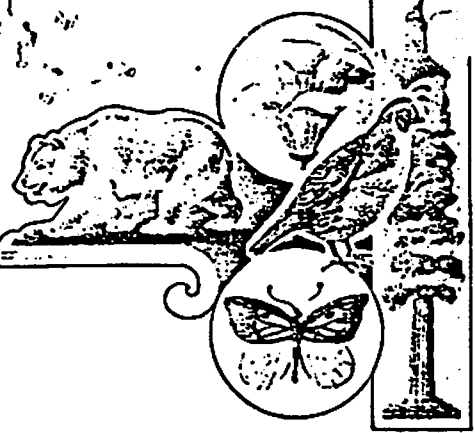

1. That they constitute at least two-thirds of the incorporators of G.G.R.C. PROGRAM POLICY COMMITTEE, INC., a California corporation.

2. That they hereby adopt the following amendment of the Articles Incorporation of said corporation:

Said Articles of Incorporation are amended to read in full as follows:

"ARTICLES OF INCORPORATION

OF

G.G.R.C. PROGRAM POLICY COMMITTEE, INC.

I

The name of this corporation shall be G.G.R.C. PROGRAM POLICY COMMITTEE, INC.

II

The purposes for which this corporation is formed are:

(a) the specific and primary purposes are to operate a Regional Center to assist and serve persons with developmental disabilities in the counties of San Francisco,

San Mateo and Marin in accordance with the Lanterman Developmental Disabilities Services Act, Chapters 1 through 11, Division 25, of the California Health and Safety Code.

Notwithstanding the foregoing statement of the specific and primary purposes, this corporation shall not engage in any activity which is not permitted of any organization described in Section 501(c)(3) of the Internal Revenue Code of 1954, as amended.

(b) The general purposes and powers are to have and exercise all rights and powers conferred on nonprofit corporations under the laws of California, including the power to contract, rent, buy or sell personal or real property, provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this corporation.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

III

This corporation is organized pursuant to the General Nonprofit Corporation Law of California. This

corporation does not contemplate pecuniary gain or profit to the members thereof and it is organized for nonprofit purposes.

IV

The principal office for the transaction of the business of this corporation is located in the City and County of San Francisco.

V

The general management of the affairs of this corporation shall be under the control, supervision and direction of the Board of Trustees. The names and addresses of persons who are to act in the capacity of trustees until the selection of their successors are:

The authorized number and qualifications of members of this corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members, and their liability to dues and assessments and the method of collection thereof, shall be as set forth in the Bylaws.

VII

The property of this corporation is irrevocably dedicated to charitable purposes, and no part of the net income or assets of this organization shall ever inure to the benefit of any trustee, officer or member thereof or to the benefit of any private individual. Upon the dissolution or winding up of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code. The assets of this corporation, including any assets held in trust, shall be disposed of in such manner as may be directed by decree of the Superior Court of the county in which the Corporation has its principal office, upon petition therefor by the Attorney General or by a person concerned in the liquidation, in a proceeding to which the Attorney General is a party."

3. That said corporation has admitted no members other than the incorporators.

KNOW ALL BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of California, and we hereby certify as follows:

FIRST: The name of this nonprofit corporation shall be: G. G. R. C. PROGRAM POLICY COMMITTEE, INC.

SECOND: The purposes for which this corporation is formed are:

A. The specific and primary purpose of this organization is to operate a Regional Center to assist and serve persons with developmental disabilities in the counties of San Francisco, San Mateo and Marin in accordance with the Lanterman Developmental Disabilities Services Act, Chapters 1 through 11, Division 25, of the California Health and Safety Code.

Notwithstanding the foregoing statement of the specific and primary purpose, this corporation shall not engage in any activity which is not permitted of any organization described in Section 501(c)(3) of the Internal Revenue Code of 1954, as amended.

B. 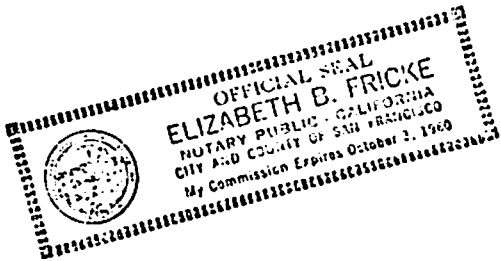
