## **GGRC's New Service Development Priorities for 2023-2024**

Regional Centers have the opportunity to submit a Community Resource Development Plan (CRDP) proposal to California's Department of Developmental Services (DDS) in order to request start-up funding for new service development. Start-up funding awarded to regional centers is determined by DDS. Information guiding the development of this plan was provided by GGRC's stakeholders (individuals receiving services, families, service providers, community partners, etc.) and GGRC staff. Any approved new services and associated start-up funding will be posted on GGRC's website and distributed in accordance with GGRC's Request for Proposal Process.

**GGRC's request for start-up funding in the CRDP proposal will focus on the follow 2023-2024 priorities:**

- Augmentative and Alternative Communication (ACC)– (Training Resources, San Mateo, San Francisco, and Marin County)
- Coordinated Family Support (CFS) Services (provider Marin and San Francisco County)
- Housing Access Services (Provider, Marin County)
- Residential Facility (Provider of Sober Living Facility Marin, San Mateo, or San Francisco County)
- Enhanced Behavior Support (EBSH) Home with forensic support (Marin, San Francisco, or San Mateo Counties)
- Enhanced Behavior Support (EBSH) Home Behavioral Support Home with 290 Registrant Forensic Support (Marin, San Francisco, or San Mateo Counties)
- Multi-family Housing/Affordable Housing Development (Marin, San Francisco, or San Mateo Counties)
